General product application requirements (if applicable):

- 1. **CCT and POWER selections (where supplied)** IMPORTANT, where CCT colour temperature or POWER selection switching is provided, it is important to switch OFF the power before the selection is made, otherwise equipment damage may occur.
- 2. Recycling SAL encourages recycling, please consider the environment when disposing of packaging, batteries & components.
- 3. **Switching or test intervals** For optimum product performance, good design practice does not encourage 24/7 operation of lighting products without the provision of a routine switching or regulatory test cycle. As a guide for continual operation installations, a twelve (12) hour duration for Industrial and Commercial applications and a six (6) hour duration for Residential applications should be considered.
- 4. **Product maintenance** In line with the relevant design standards and to protect your investment, it is important to have in place a routine cleaning program that reflects the installation environment and maintains the product in a clean and functional condition.

IMPORTANT - The supply must be isolated before any product maintenance or cleaning is conducted. In addition, damage to ANY cable or cord supplied with the product must be addressed as follows; For attachment type X having a specially prepared cable, if the external flexible cable is damaged, it must be replaced by an equivalent cable exclusively available from the manufacturer or authorised installer. For attachment type Y, if the external flexible cable is damaged, it must be exclusively replaced by an equivalent cable by the manufacturer or authorised installer.

For attachment type Z, if the external flexible cable is damaged, the cable cannot be replaced and the luminaire must be destroyed.

- 5. Adverse, corrosive and coastal installation environments Unless the product is specifically designated for such applications in these installation instructions, which is supported by a professional maintenance program; installation of equipment in such environments is not recommended.
- 6. **Dimming products** Dimming circuits and product compatibility must be validated by the installer before installation; SAL cannot be responsible for third party changes in dimmer compatibility.
- 7. Suspended products For installation safety, any suspended products must NOT be installed in high air movement spaces or locations subject to impact.
- 8. Light source replacements (Non-replaceable light sources) The light source of the product is deemed not replaceable, when the product reaches its end of life the complete product, it must be replaced by a qualified installer. (Non-user replaceable light sources) The light source of the product must only be replaced by the manufacturer or qualified installer. Caution, risk of electric shock.
- 9. Interior downlights and sensors with remote drivers The mounting facilities provided for the transformer/driver (if any), need only be utilized if in the application of the product is required by AS3000. Drivers are not designed for installation environments that restrict conventional airflow.
- 10. **Floodlight products** Unless nominated aiming restrictions or installation parameters apply, products are designed for installation environments between ground and 15 metres in height, subject to the desired optical performance being achieved.?
- 11. **Emergency enabled products** In the interest of transport and safety, emergency products are supplied with the battery disconnected. In addition to specific emergency commissioning instructions, this battery MUST be connected at the time of installation.






12. **Specific installation procedures** (if any) - this device must be installed by a licensed electrician:

Operation instruction:

- 1. Switch off the power
- 2. Terminate the conductors as per the wiring diagram
- 3. Switch on the power
- 4. To pair this product with a PIXIE dimmer or switch:
- (a) Turn off the light that is controlled by the PIXIE dimmer or switch.
- **(b)** Then quickly tap the button of the PIXIE dimmer or switch 4 times
- (c) Observing its LED indicator flashing blue and white, quickly press the button of the PIXIE Multiway Control 4 times within 30 seconds
- **(d)** When the LED indicator flashes twice and solid for 2 seconds, the pairing is successful.
- **(e)** Test function by pressing the button



8.3 How to pair with a PIXIE smart dimmer or switch – without the phone

- 1. Ensure the PIXIE smart dimmer or switch is in the OFF state
- 2. Quickly press the button of the PIXIE dimmer or switch 4 times
- 3. Observing its LED indicator flashing blue and white, the PIXIE dimmer or switch is in the pairing mode
- 4. Quickly press the button of PIXIE Multiway Control 4 times within 30 seconds
- 5. When the LED indicator flashes twice and keeps solid for 2 seconds, the pairing is successful

8.4 How to pair with a PIXIE smart dimmer or switch – with the (PIXIE app) phone (Recommended)

- 1. Ensure the PIXIE smart dimmer or switch is added into the App, either PIXIE or PIXIE PLUS
- 2. Ensure the PIXIE smart dimmer or switch is in the OFF state
- 3. Stand close to the PIXIE Multiway Control
- 4. Launch the App, navigate to "Devices", then find the PIXIE smart dimmer or switch that needs to be paired, go to device detail page by pressing its icon
- 5. Tap the top right three dots on the app, then tap "Pairing" in the pop-out list
- 6. Quickly press the button of the PIXIE Multiway Control 4 times within 30 seconds, when the LED indicator flashes twice and keeps solid for 2 seconds, the pairing is successful
